# **Clinical Guidelines Summary**

#### AIM

This guidance aims to support health professional decision making in relation to a child / young person presenting intoxicated with alcohol and/or other substances at Emergency Departments (ED) in Lanarkshire. The guidance will support professional decision making, promote safer discharge and inform appropriate follow up.

This guidance provides a framework to support staff in ED in relation to:

- Raising a Notification of Child Protection Concern (NOCPC).
- Raising Adult Support and Protection Concern (AP1) if age 16/17 years old and the young person who is not on a Compulsory Supervision Order.

### **Definitions**

Under the Children and Young People (Scotland) Act 2014, a 'child' is defined, for the purposes of all Parts of that Act, as someone who has not yet attained the age of 18. The individual young person's circumstances and age will dictate what legal protections are available. The Adult Support and Protection (Scotland) Act 2007 can be applied to over 16's when the criteria are met.

### **ROLES AND RESPONSIBILITIES**

- If health staff suspect that a child or young person has experienced or is at risk of abuse or neglect, they must provide any immediate medical care required, gather information from the child or young person's medical records, and contact social work standby services.
- Where assessment of the child/young person indicates potential risk of significant harm, staff must follow Child Protection/Adult Support and Protection processes to formally raise their concern. Staff must ensure that senior practitioners are involved in any decision-making process.
- Following assessment, the child/young person should not be discharged until the Emergency Medicine Physician is satisfied that the child/young person is medically fit for discharge and the parent/carer is involved.
- Parent/carer should be advised a NOCPC may lead to a full multi agency needs/risk assessment and commencement of Child Protection processes.
- If child/young person is medically fit for discharge and responsible adult cannot be contacted (if under 16 years) staff should contact Social Work for advice.

Where there may be a child protection concern, information may be lawfully shared without the need for consent to be obtained from the individual(s) to whom the information relates (National Guidance for Child Protection in Scotland 2021).
